

## **B2M HOLDER WEEK JULY & AUGUST**

### **“€1,500 Prize Split Between 2 Winners”**

#### **1. ORGANIZING ENTITY**

**BITCOINFORME, S.L.** (hereinafter "Bit2Me"), with registered office at Calle Germán Bernacer, 69, 03203, Elche, Alicante, SPAIN, and Tax ID No. B-54835301, registered with the Commercial Registry of Alicante in Volume 3828, Folio 110, Entry 1, Sheet A-143230, is the owner of the website: <https://bit2me.com/> and the Bit2Me app (iOS/Android), through which access to the Bit2Me platform is provided.

#### **2. PURPOSE**

The aim of the promotional campaign “**B2M HOLDER WEEK JULY & AUGUST**” is to encourage the holding and locking of B2M tokens on the Bit2Me platform (accessible at <https://bit2me.com/en> and via the “Bit2Me” app for Android and iOS) through a prize draw with cash rewards. Eligible users must hold a minimum position in the 6 or 12-month locking pools at the time of the funds snapshot on **August 11, 2025, at 23:59 (CEST, Madrid time)**, and meet the requirements outlined in Clause 4 of these legal terms.

#### **3. PARTICIPATION PERIOD**

The promotion will run from **July 29, 2025**, and will end on **August 11, 2025, at 23:59 (CEST)**.

---

#### **4. ELIGIBILITY REQUIREMENTS**

Participation is open to companies and individuals of legal age who meet the following criteria:

- Be of legal age and have a registered and verified account on the Bit2Me platform. Verification may take several days and is subject to compliance with current anti-money laundering regulations as well as the platform's Terms and Conditions.
  - Hold locked B2M tokens in one of the following Bit2Me pools at the time of the funds snapshot on **August 11, 2025, at 23:59 (CEST)**, under the following conditions:
    - **At least 10,000 B2M locked in the 6-month pool:** grants 1 entry per B2M token locked in that pool.
    - **At least 50,000 B2M locked in the 12-month pool:** grants 2 entries per B2M token locked in that pool.

## 5. PRIZES AND DELIVERY

Among all participants who meet the conditions outlined in Clause 4, **two (2) cash prizes of €750 each (in B2M)** will be drawn, totaling **€1,500** in prizes.

To determine entries, Bit2Me will take a snapshot of balances on **August 11, 2025, at 23:59 (CEST)** to calculate how many B2M tokens are locked in the 6- and 12-month pools per user:

- If the user has at least **10,000 B2M in the 6-month pool**, they will receive **1 entry per B2M token**.
- If the user has at least **50,000 B2M in the 12-month pool**, they will receive **2 entries per B2M token**.

These entries will be automatically counted and used as valid tickets for a random draw.

During the week following **August 11**, Bit2Me will contact the winners via the email associated with their account. The prize will be paid in B2M tokens directly to the winner's

B2M wallet on the Bit2Me platform within a maximum of **30 calendar days** from the end of the campaign.

Winners must explicitly accept the prize within **10 calendar days** from the notification date. If no confirmation is received, or if the prize cannot be delivered for reasons beyond Bit2Me's control, or the user fails to meet the requirements, the prize will be assigned to the next alternate drawn by the system.

Bit2Me will select **two (2) winners** and **two (2) alternates**, who will only be contacted if necessary.

Employees of Bit2Me or any person or profile that, in the organizer's view, has fraudulently manipulated participation or violated these terms are **excluded**.

Bit2Me reserves the right to modify, suspend, or cancel this promotion if justified by circumstances such as force majeure or to ensure proper conduct.

## 6. TAX OBLIGATIONS

The prize may be considered a **capital gain** under Article 33.1 of **Law 35/2006** (Spanish Income Tax Act).

Where withholding or tax prepayment is applicable under Article 101.7 of the same law, Bit2Me will apply the corresponding withholding and remit it to the Tax Authority on the user's behalf. Bit2Me will also provide a **tax certificate** detailing the full prize value and the amount withheld, **without deducting** the withholding from the prize paid.

The user is solely responsible for their **personal tax obligations**, including any declarations, payments, or adjustments related to the prize. Bit2Me shall not be liable for any user tax non-compliance due to lack of information, errors, or delays.

## 7. PERSONAL DATA PROTECTION

In accordance with **Regulation (EU) 2016/679 (GDPR)** and **Organic Law 3/2018 (LOPDGDD)**, participants are informed that their personal data will be included in a database owned by **BITCOINFORME, S.L.**, for the purposes of managing participation in the

draw and maintaining commercial relationships via electronic means, based on the legitimate interest of Bit2Me Group companies (see list at [www.bit2me.com](http://www.bit2me.com)).

Participants may exercise their **data rights** (access, rectification, deletion, limitation, objection, portability) by emailing [rgpd@bit2me.com](mailto:rgpd@bit2me.com). After the data processing purpose ends or data deletion is requested, data will be blocked and held available to authorities for the legally prescribed time.

**Fields marked with an asterisk** in the registration form are required. Failure to provide them will prevent registration.

Participants confirm they are the legitimate owners of the data submitted. Any false data provided is the sole responsibility of the participant.

Participants have the **right to withdraw consent for commercial data processing** and may lodge complaints with the **Spanish Data Protection Authority (AEPD)** at: <https://www.aepd.es/en>.

Bit2Me shall not be liable for interruptions, errors, or any utility loss users attribute to the campaign, or for issues accessing pages or submitting entries online. Bit2Me is not responsible for any offensive or inappropriate content users may submit.

Bit2Me is not liable if a user fails to complete the verification process before the end date due to high demand or any other reason.

Any fraudulent activity will result in **immediate disqualification** and loss of any early access benefits. Bit2Me reserves the right to take legal action against any fraudulent behavior.

## 9. LIABILITY

Bit2Me reserves the right to make changes or cancel the campaign for justified reasons or to improve its performance.

Bit2Me accepts no liability for temporary unavailability or failure of the campaign, user expectations, or failure to participate due to user error or omission.

## 10. ACCEPTANCE OF LEGAL TERMS

Participation implies **acceptance of all terms**. If a participant does not accept these terms, they will be excluded and Bit2Me will be released from any obligations toward them.
