

Terms and Conditions of the "Bit2Me Fourth Anniversary" Raffle

1. IDENTIFICATION OF THE ORGANIZING ENTITY

BITCOINFORME, S.L. (hereinafter Bit2Me), with registered address at Calle Germán Bernacer, 69, 03203, Elche, Alicante, ESPAÑA, and with N.I.F. B-54835301, registered in the Mercantile Register of Alicante, volume 3828, folio 110, Entry 1 with Sheet A-143230, is the owner of the website: <https://bit2me.com/> and of the APP (iOS/Android) through which the Bit2Me Platform is accessed.

2. OBJECT

Due to the 4th anniversary of the B2M token, Bit2Me has developed this raffle with the purpose of rewarding B2M Holder users within the Bit2Me spaces (accessible at <https://bit2me.com/> and in the «Bit2Me» APP on Android and iOS) who comply with the requirements established in these terms and conditions.

Specifically, those Bit2Me users who are holders of the B2M token and comply with the requirements indicated in clause 4, may opt to be chosen as winners of any of the following prizes (1 time for each of the 4 segments):

2,000,000 B2M distributed among 20 winners, at a rate of 100,000 B2M for each winner, in the following way:

- 500,000 B2M to be distributed among users who have held an amount equal to or greater than 10,000 B2M for more than six (6) months at the end of the campaign.
- 500,000 B2M to be distributed among users who have purchased, at least, 1,000 B2M during the campaign, and these have been held until the end of the campaign (holding means not selling them).
- 500,000 B2M to be distributed among users who have made a new lock or have added an additional amount of funds of, at least, 1,000 B2M to the 12-month pool during the campaign. Movements to the 12-month pool will count from: Wallet, flexible pool, 3-month pool, and 6-month pool.
- 500,000 B2M to be distributed among users who have burned, at least, 1,000 B2M during the campaign.

3. PARTICIPATION PERIOD

The participation period to qualify for the benefit subject to this promotion will begin on October 30, 2025 and will end on December 31, 2025 at 23:59 hours (11:59 PM), both included.

4. RULES AND CONDITIONS FOR PARTICIPATION

All natural persons of legal age, residing in any country admitted on the Bit2Me platform (which can be found at the following link: <https://bit2me.com/en-el-mundo>), and who comply with the following requirements, may participate in the promotion:

- Have a registered and verified account at <https://bit2me.com/>. We remind you that verification can sometimes take several days and is subject to compliance with current legal regulations.
- Expressly accept these terms and conditions, by registering on the landing page enabled for this purpose at the URL: <https://bit2me.com/register?prm=B2M4BD>.
- Have performed any of the following actions during the campaign period:
 - Hold at least 10,000 B2M for more than six (6) months at the end of the campaign. This action will grant one (1) entry for every 1,000 additional B2M held. **Example:** If at the end of the campaign I have held 20,000 B2M for more than six (6) consecutive months, I will have 11 entries (1 + 10) – Base entry for a minimum of 10,000 B2M plus 1 additional entry for every 1,000 additional B2M.
 - Buy, at least, 1,000 B2M and hold them until the end of the campaign. Every 1,000 B2M purchased and held will grant the user one (1) entry. B2M sold during the period will be considered as NOT held (redeemed B2M will not be discounted).
 - Lock, at least, 1,000 new B2M in the 12-month pool during the campaign period. This action will grant the user one (1) entry for every 1,000 B2M locked in the 12-month pool.
 - Redeem, at least, 1,000 B2M during the campaign period. This action will grant the user one (1) entry for every 1,000 B2M redeemed.
- These entries will be summed automatically and will be used as valid entries in the random raffle.
- At the end of the campaign, all entries will be summed, after which a random selection of the winners will be made.
- Users can participate in one or more actions simultaneously to obtain the corresponding prizes.
- If any sale of B2M is made during the participation period, all the entries obtained from segments 1 (hold for equal to or more than 6 months) and 2 (buy and hold) will be lost.

Employees of Bit2Me, nor those persons or profiles that, according to the organizer's criteria, have fraudulently manipulated their participation or violated these terms and conditions, may not participate in this promotion.

Bit2Me reserves the right to make changes to the raffle during its development, if any cause occurs that prevents its successful conclusion or in order to improve its progress.

5. SELECTION AND COMMUNICATION OF WINNERS

On January 15, 2025, the 20 winners will be randomly chosen and 10 substitutes will be established for the prizes indicated in clause 6 of these terms and conditions among those users who comply with the requirements indicated in clause 4 and are selected in the raffle carried out through a random winner platform (<https://www.random.org/lists/>).

During the week following January 15, 2025, Bit2me will contact the winners through the email linked to their account. The amount of the prize will be credited in the B2M token directly to the winner's B2M wallet registered on the Bit2Me platform, within a maximum period of thirty (30) calendar days counting from the campaign end date.

Winners will have a period of ten (10) calendar days from the date of notification to expressly accept the prize. In case of not receiving confirmation from the winner within this period, of the impossibility of delivering the prize due to causes outside of Bit2me, or if the user fails to comply with the requirements established in these terms and conditions, the prize will be assigned to the next participant in the list of substitutes automatically generated by the system during the raffle.

Bit2Me will select a total of twenty (20) winners and twenty (20) substitutes. Substitutes will only be contacted in case of waiver, disqualification, or impossibility of contacting any of the main winners.

Bit2Me reserves the right to modify, suspend, or cancel this promotion in case of justified causes, *force majeure* situations, or in order to guarantee its adequate development.

6. VALUE AND NATURE OF THE PRIZE

Each winner of the raffle will receive the following prize until the total amount of 2,000,000 B2M is completed:

- 100,000 B2M, with an equivalent value of approximately 1,350 EUR, if selected by raffle in the B2M holding section for more than 6 months.
- 100,000 B2M, with an equivalent value of approximately 1,350 EUR, if selected by raffle in the section for purchasing at least 1,000 B2M during the campaign.
- 100,000 B2M, with an equivalent value of approximately 1,350 EUR, if selected by raffle in the B2M locking section for 12 months.
- 100,000 B2M, with an equivalent value of approximately 1,350 EUR, if selected by raffle in the section for redeeming at least 1,000 B2M during the campaign.

The specific conditions for the delivery of the prizes will be communicated to each prize winner of the campaign.

7. TAX OBLIGATIONS

The prize that the user receives within the framework of this promotion may be considered a capital gain in accordance with the provisions of article 33.1 of Law 35/2006, of November 28, on Personal Income Tax (IRPF).

In cases where withholding or payment on account is applicable, in accordance with article 101.7 of the aforementioned Law 35/2006, Bit2Me will apply the corresponding tax withholding and will proceed to deposit said amount on account in the name of the user with the Tax Agency. Bit2Me will also provide the user with a tax certificate, detailing the full amount of the prize and the withholding practiced, without deducting the amount of said withholding from the final prize paid.

The user will be solely responsible for complying with their personal tax obligations derived from participation in the promotion, including those related to the declaration, taxation, or regularization of the prize obtained. Consequently, Bit2Me will be exempt from any liability derived from tax non-compliance that may occur by the user.

8. PERSONAL DATA PROTECTION

In compliance with the provisions of Regulation (UE) 2016/679 (GDPR), Organic Law 3/2018 (LOPDGDD), and other applicable regulations, we inform participants that their personal data will be incorporated into a Database owned and managed by BITCOINFORME, S.L.. The purpose is the management and participation in the raffle, as well as the maintenance of commercial relations by electronic means based on the legitimate commercial interest of the Bit2Me Group companies (www.bit2me.com).

Participants are recognized the exercise of the rights of access, rectification, deletion, limitation, opposition, and portability of their data, which they may exercise by sending an email to rgpd@bit2me.com. Once the purpose of processing has been concluded or deletion is requested, the data will be blocked at the disposal of the Administration, Judges, and Courts, for the legal prescription periods.

Personal data marked with an asterisk on the raffle registration form are essential; their absence would imply the impossibility of registration and validation as a participant. The participant guarantees that they are the owner of the personal data provided and that they are authentic. The participant will be responsible for the consequences of providing false data.

Participants have the right to withdraw their consent for commercial purposes for data processing by the Bit2Me Group, and they are entitled to file a claim with the Spanish Data Protection Agency (<https://www.aepd.es/es>).

9. PENALTIES IN CASE OF FRAUDULENT USE

Bit2Me will be exempt from any liability for damages due to the temporary lack of availability or continuity of the campaign's operation, the defrauding of the utility that users may have attributed to it, and access through the Internet. Bit2Me will also be exempt from the acts or omissions of the participants that impede their correct participation.

Bit2Me is not responsible for possible inappropriate or offensive content that users may upload.

Bit2Me is not responsible if any user/client does not complete the process to have their account verified, or if it could not be concluded before the end date due to high demand.

The verification of any of these practices will entail automatic disqualification and prohibition from participating in the raffle, as well as the loss of early access if granted. Bit2Me reserves the right to take legal action against those persons who carry out any type of act susceptible to be considered manipulation or falsification of the raffle.

10. LIABILITY

These Terms and Conditions are subject to Spanish legislation. Any claim related to the raffle must be sent in writing to support@bit2me.com. In case of any discrepancy or controversy regarding the application or interpretation of these terms and conditions, and in the absence of an amicable agreement, the participant accepts to submit to the jurisdiction of the courts and tribunals of the city of Alicante.
