

LEGAL TERMS AND CONDITIONS OF THE "Gana BTC Juntos" PROMOTION

Flash Referral Programme | May 2026 Sprint

1.- Identification of the Organising Company

BITCOINFORME, PSC, S.L. (hereinafter, **Bit2Me**), with registered office at C/ Germán Bernacer, 69, 03203, Elche, Alicante, Spain and Tax ID (CIF): B54835301, authorised by the National Securities Market Commission (CNMV) as a Crypto-Asset Service Provider (CASP) in accordance with Regulation (EU) 2023/1114 (MiCA) by resolution dated 28 July 2025, has organised the promotion entitled "Gana BTC Juntos" (hereinafter, the **Promotion**), which shall be conducted in accordance with these Terms and Conditions.

2.- Objective

The purpose of this Promotion is to award prizes to referrers and referred users of the Bit2Me platform (accessible at <https://bit2me.com> and via the "Bit2Me" app on Android and iOS). This applies to new users registering through a referral link, as well as existing Bit2Me users, in accordance with the conditions established in these legal terms.

Bit2Me has designed this referral programme in good faith, and participants are expected to act with the same integrity. The intent of this programme is to reward users who actively use Bit2Me services and refer new users for that purpose. Users who violate this principle will be excluded from the programme as set out in section eight of these terms.

3.- Participation Period

The "Gana BTC Juntos" promotion will be active from **7 May 2026 at 00:00 CET until 21 May 2026 at 23:59 CET**, or until the 1,000 available reward slots have been exhausted, whichever occurs first.

Bit2Me will provide an indicative count of available slots through the platform's official channels (website and app); however, this counter does not constitute a real-time guarantee.

4.- Rules and Conditions for Participation

The Promotion is open to all natural persons of legal age, residing in Spain, who have received a formal communication via email or app push notifications, and who meet the following requirements.

If you are joining as a referred user (new user):

- **Action 1. Bit2Me Account Verification:** Hold a personal account registered with Bit2Me and complete the verification process on the Bit2Me Platform. Please note that verification may occasionally take several days and is subject to compliance with current legal regulations.
- **Action 2. Minimum First Purchase of €100 via Bit2Me Wallet:**
 - Hold a verified personal account on the Bit2Me Platform.
 - Complete an initial purchase of crypto-assets using the account's Bit2Me Wallet for a minimum amount of **€100** (at the exchange rate valid at the time of the transaction).
 - The first purchase must be made via **card or fiat deposit**. Users cannot participate by receiving crypto through Bpay or crypto deposits.

If you are the Referrer (existing user):

- Invite a friend or family member via the referral link in the "Referrals" section of the Bit2Me app during the promotion period.
- Ensure your referred user completes an initial crypto-asset purchase of at least €100 using their verified Bit2Me Wallet.
- A single Referrer can earn a maximum of **20 rewards** during the Sprint period.

Employees of Bit2Me and profiles found to have manipulated their participation are ineligible to participate.

Reward Lock-up Period: Rewards obtained under this promotion cannot be withdrawn by the beneficiary until **30 days** have passed since the date the referred user registered and verified their account on the Bit2Me platform. During this period, rewards cannot be withdrawn, transferred, or converted into fiat currency. After the 30-day period, and provided all other conditions are met, rewards can be withdrawn using the methods available on the platform.

Bit2Me reserves the right to modify the promotion while it is in progress if any cause arises that prevents its successful completion or to improve its delivery.

5.- Prizes

Participants who complete the actions specified in the promotion will receive the following rewards:

- **Referrer:** €10 equivalent in Bitcoin (BTC) at the exchange rate valid at the time of payment.
- **Referred User:** €15 equivalent in Bitcoin (BTC) at the exchange rate valid at the time of payment.

Rewards will be credited once the 30-day lock-up period mentioned in section four has elapsed, following verification that no fraudulent activity has occurred.

The programme is limited to **1,000 reward slots**. A slot is considered used once the referred user's first purchase is confirmed by the system within the Sprint period. Once the slots are exhausted, additional registrations will not generate a Sprint reward.

Mandatory Disclosure (Regulation (EU) 2023/1114, MiCA):

The amounts of €10 (referrer) and €15 (referred) are paid in BTC at the exchange rate at the time of payment. The value in EUR may fluctuate thereafter based on the market price of Bitcoin. This is a commercial communication from Bit2Me and does not constitute investment advice.

Specific details regarding the reward and its delivery will be provided to each user when they access the promotion or during the account creation process on the Bit2Me Platform.

Winners may waive the reward; however, no alternative prize will be offered, and such a waiver does not entitle the user to any indemnity or compensation.

Bit2Me is exempt from any liability in the event of errors in the data provided by users that prevent their identification.

6.- Tax Obligations

Specific details regarding the reward—and its delivery in particular—will be communicated to each user at the moment they access the promotion or during the account creation process on the Bit2Me Platform.

Winners reserve the right to waive any reward obtained. However, please note that no alternative prizes will be offered under any circumstances, and such a waiver shall not grant any right to indemnity or further compensation.

Bit2Me shall be exempt from any and all liability in the event that errors in the information provided by users prevent their successful identification or the processing of the reward.

7.- Protection of Personal Data

In compliance with **Regulation (EU) 2016/679** of the European Parliament and of the Council of 27 April 2016 (GDPR), Spanish Organic Law 3/2018 (LOPDGDD), and all other applicable data protection regulations, participants are hereby informed that their personal data will be incorporated into a database owned and managed by **BITCOINFORME, PSC, S.L.** The purpose and legal basis for this processing is the management of the promotion, as well as the maintenance of commercial relations via electronic means, based on the legitimate commercial interests of the **Bit2Me Group** companies (a full list of companies is available at www.bit2me.com).

Participants are entitled to exercise their rights of **access, rectification, erasure, restriction, objection, and data portability**. These rights may be exercised by sending an email to rgpd@bit2me.com. Once the processing purpose has concluded or upon a request for erasure, data will be restricted and kept available only for the Administration, Judges, and Courts to address potential legal liabilities arising from the processing, in accordance with applicable statute of limitations.

The participant guarantees that they are the legal owner of the personal data provided and that such data is authentic. The participant shall be held solely responsible for any consequences arising from the provision of false information.

Furthermore, participants are informed of their right to **withdraw consent** for commercial purposes at any time and their right to lodge a complaint with the Spanish Data Protection Agency (AEPD) at <https://www.aepd.es/es>.

8.- Penalties for Fraudulent Use

Bit2Me reserves the right to classify any behaviour that appears abusive or malicious as fraud. This includes, but is not limited to:

- Identifying oneself using a false identity or using third-party identities without consent.
- Self-referring via additional accounts or accounts controlled from the same device or IP address.
- The Referrer directly or indirectly financing the Referred user's first purchase for the sole purpose of claiming rewards.

Should Bit2Me become aware, directly or indirectly, that a participant has committed fraud, abuse, or acted in bad faith as defined by these terms and applicable law, their ability to benefit from the referral programme will be **permanently revoked**.

Bit2Me assumes no responsibility for any inappropriate or offensive content that users may upload at their own risk to the communication channels used for this promotion. Furthermore, Bit2Me is not liable if a user fails to pass the account verification process, or if high demand prevents the verification from being completed before the promotion's closing date.

Evidence of any such practices will result in **automatic disqualification** and a ban from the promotion. Bit2Me reserves the right to take legal action against any individual suspected of manipulating or falsifying the campaign.

9.- Liability

Bit2Me reserves the right to modify or cancel the promotion while it is in progress should any cause arise that prevents its successful completion or to improve its delivery.

Bit2Me shall be exempt from any liability for damages resulting from a temporary lack of availability or continuity of the campaign's operation.
